Proposed Prohibition of Waiting

- 1. Weaverham Road (west side) From a point 15 m north of its junction with Mere Lane for a distance of 44 m in a southerly direction
- 2. Mere Lane (both Sides) From its junction with Weaverham Road for a distance of 17 m in a westerly direction.
- 3. Mere lane (north side) From a point opposite the easterly kerbline of Blake Lane for a distance of 40 m in a easterly direction..
- 4. Mere lane (north side) From a point 20 m east of its junction with Ash Road to its junction with Grange Road
- 5. Mere lane (south side) From a point 20 m east of its junction with Ash Road to a point 21 metres west of its junction with Ash Road
- 6. Mere Lane (south side) From its junction with Grange Road to a point 10 metres east of Fir Lane.
- 7. Grange Road (north side) From its junction with Mere Lane to a point 14 metres west of Poplar Close.
