**Delamere Park - Proposed 20 mph Speed Limit**

In January 2016 the Council's Cabinet voted to introduce 'signed only' 20 mph speed limits, where appropriate, on all residential roads and outside schools.

In 2019 a 20 mph speed limit was proposed for part of the Delamere Park estate. Following requests to extend the scheme to the whole estate a new assessment was carried out.

A 20 mph speed limit was recommended for the whole estate, the roads affected are highlighted in blue on the attached plan.

Traffic calming measures will not be included in the proposal. All new posts and their signs which have already been installed as part of the original proposal will be removed if the scheme is given approval to go ahead.

Cheshire Police have no objections to the proposal to extend the 20 mph speed limit.

A Traffic Regulation Order for the new speed limit will be advertised during week commencing 28 June 2021.

All objections and other representations relating to the Order must be made in writing to the undersigned or by email to the address below by 23 July 2021 and objections must specify the grounds on which they are made.

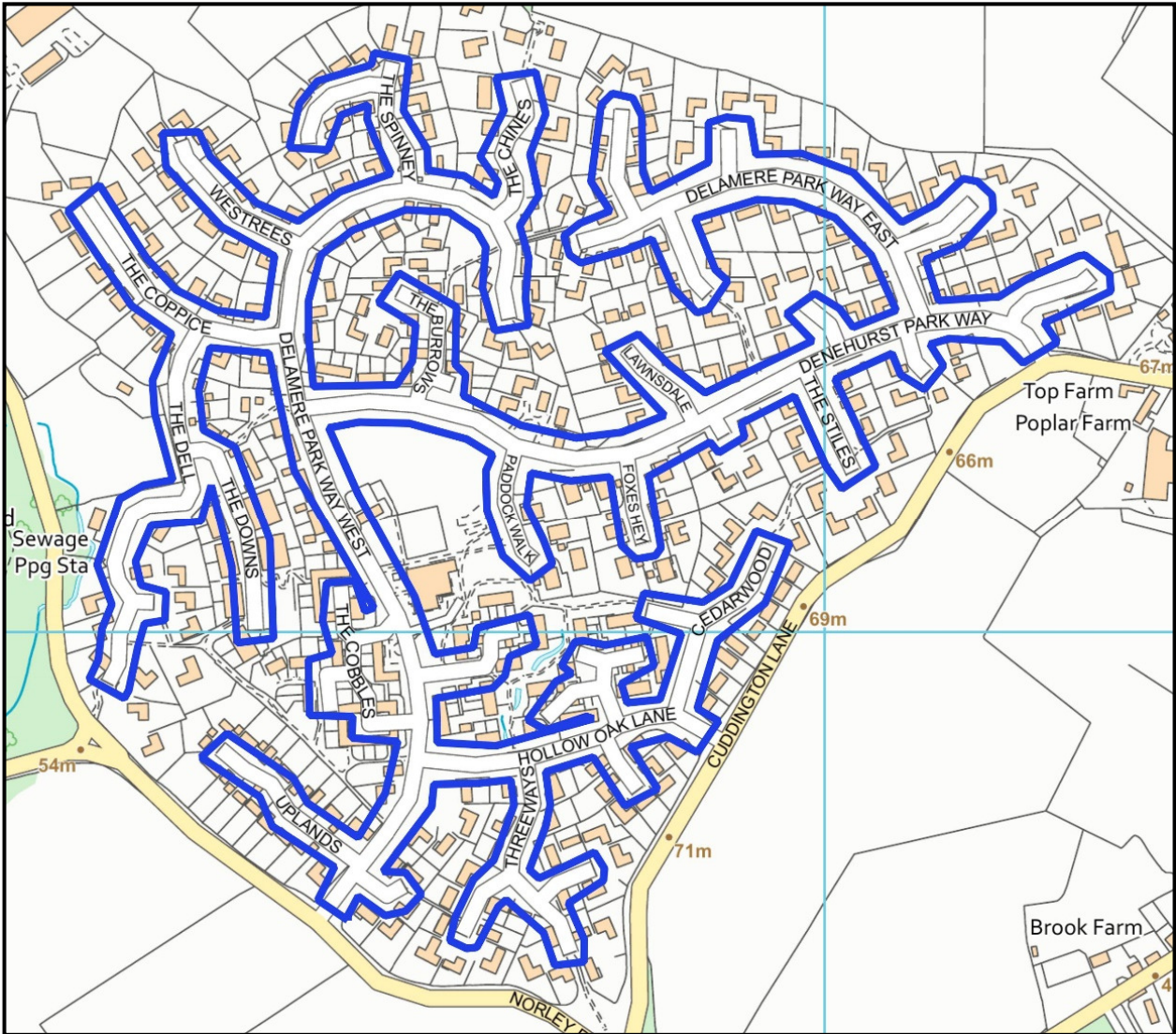

## **Frequently Asked Questions – 20 mph Consultation**

### **1. Why are the council proposing a 20 mph speed limit in my area?**

In 2013 the Government issued new speed limit guidance and asked local authorities to review limits and consider the introduction of 20 mph limit in residential areas

In January 2016 the council voted to introduce 'signed only' 20 mph speed limits on residential roads that met Department for Transport criteria and to include schools on through routes that met the criteria.

The programme includes over 225 schemes and is currently in year four of a four year programme.

### **2. How much will the proposals cost for my area?**

The proposed areas differ in size; therefore it is difficult to give an exact cost for each area at this stage.

There are 75 identified schemes for this year's programme and the overall budget for this year is £200,000, it is estimated that each area will cost between £600 and £3,500 but this is only a rough guide.

### **3. Why is my road included within the proposed 20 mph speed limit?**

Your road has been included in the 20 mph proposals because it meets the criteria for a 'signed only' 20 mph speed limit. To meet the criteria most roads must have an average speed below 24 mph.

### **4. Do the proposals consist of traffic calming or other physical measures?**

The proposals do not include traffic calming or physical measures such as speed humps.

Roads that require traffic calming or other measures will not be included in the programme.

### **5. How is the proposed 20 mph speed limit going to be enforced?**

As with all speed limits, the proposed 20 mph speed limit will be enforced by the police based on evidence of a speeding problem.

The proposed scheme in your area is to be introduced on all roads that meet the criteria for 'signed only' 20 mph speed limits; with average speeds below 24 mph, compliance should not be an issue.

To ensure that compliance is being met, should the scheme go ahead, all speed monitoring will be repeated, and any evidence of non-compliance will be used by the police to prioritise their enforcement programme.

## **6. How will the speed limit be signed?**

It is a legal requirement that all speed limits must be signed.

For Delamere Park this will require the 30 mph signs at the access points from Norley Road and Cuddington Lane to be changed to 20 mph signs.

Smaller repeater signs will be required approximately every 200m, these will be paced on existing lighting columns.

All new posts and their signs that have been installed as part of the original proposal will be removed. The Council's contractor will work with the Estate Management to reinstate the verges.

## **7. You have included short Cul-de-Sac roads where it would be impossible to speed.**

The purpose of the 20 mph programme is to introduce appropriate speed limits.

If Cul-de-Sac roads, which lead off roads with a 20 mph speed limit, were omitted from the scheme the council would be legally required to install 30 mph speed limit terminal signs at the access to the Cul-de Sac roads. This would increase costs and lead to driver confusion and generate many complaints.
